This agreement is made, and hereby entered into on this _____ day of _____, _____ by and between Amazing German Shepherds, hereafter referred to for the purpose of setting forth the terms and conditions of the purchase by the buyer of a pure bred German Shepherd, from the litter whelped on _____ out of.

The seller agrees to sell and the buyer agrees to buy one _____ male _____ female German Shepherd dog. (herein after "animal") from the above described litter. The seller warrants that the above described animal is in good health and free of communicable diseases at the time buyer assumes ownership. Buyer agrees to have animal examined by licensed veterinarian within 24 hours, (not including weekends or holidays) of receipt animal. If as result of the examination, the veterinarian determines that animal is not in good health, then the buyer shall elect to keep animal or return the animal to seller for a refund. Buyer must have written report stating that animal was in ill, health status when examined by licensed veterinarian to receive refund from seller. Absolutely no other reasons or excuses will be accepted by seller regarding refunds.

If animal is diagnosed with crippling hip dysplasia for up to two years of age, the animal will be replaced by a healthy animal of equal or greater value by seller. The diagnosis must be accompanied by statements from veterinary practice. This statement must be accompanied by a written evaluation by the Orthopedic Foundation for Animals (O.F.A.). The buyer agrees that the seller will not be liable for health problems if animal shows evidence of neglect, abuse and poor nutrition. This diagnosis must be accompanied by statements from two neutral veterinarians. If Buyers ignore conditions of this contract. Seller will be released of liability.

The buyer agrees to maintain preventive care of animal in regards to hip dysplasia, such as proper nutrition, and preventing stress injuries, such as running until at least 24 months of age. (Not allowing the animal to jump heights taller than itself at the shoulder, NO FORCED EXERCISE. Ownership of the animal shall be transferred to buyer for the sale price of \$ _____ to be paid in full on or before _____. Only after the full amount of agreed upon amount is paid, may the animal be removed from the sellers premises. If the balance is left unpaid by such date as of the _____, this agreement shall be canceled at the seller's option, and the buyer shall forfeit the deposit given hereafter. If, in the event an animal from the described litter is not accepted by the buyer the deposit will be used toward purchase of an animal from next available litter. The buyer agrees that this animal will not be used for breeding purposes until it is at least 24 months of age, to another German Shepherd. Registered with AKC or other certified dog registry, (SV, CKC) and only after it has (O.F.A.) certification, for both hips and elbows. Should buyer breed the animal before all of the requirements listed in this section are met the buyer agrees and acknowledges the seller;s rights to execute their rights to repossess the animal that this contract pertains to.

This agreement is made and signed by both parties to insure the well-being and protection of this animal, if any part of this agreement is breached, the seller is released from any further obligation hereunder.
